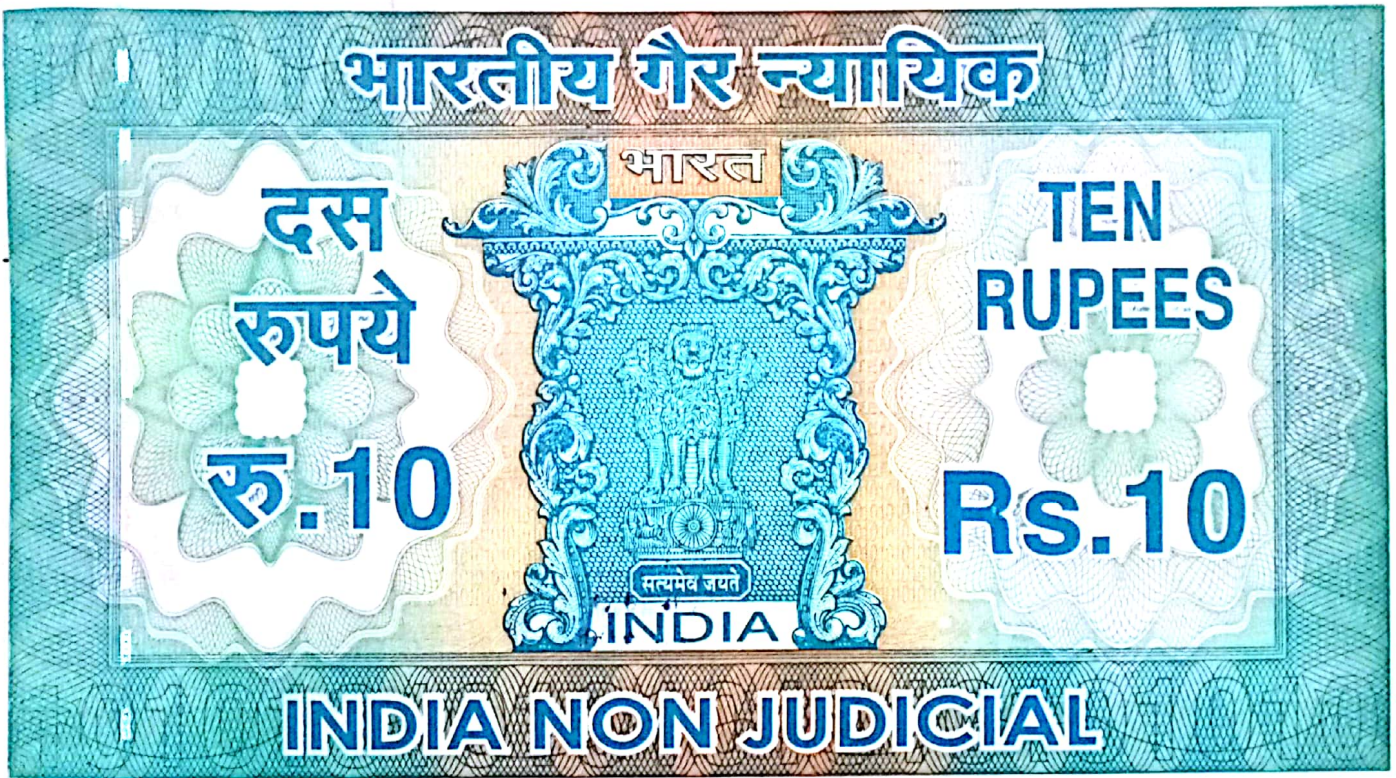
1. Objectives of MoU



3. Duration of MoU


